## ENTRY OF ORDER

On December 15, 1994, Glenn Leon Heigerick, DO, executed a Voluntary Surrender of his Certificate to practice osteopathic medicine and surgery with a consent to revocation, which document is attached hereto and fully incorporated herein.

In consideration of the foregoing and of Doctor Heigerick's express waiver of the provision of section 4731.22(B), Ohio Revised Code, requiring that six (6) Board members vote to revoke said certificate, it is hereby ORDERED that Certificate No. 34-000327 authorizing Doctor Heigerick to practice osteopathic medicine and surgery be permanently REVOKED, effective December 15, 1994.

This Order is hereby entered upon the Journal of the State Medical Board of Ohio for the fifteenth day of December, 1994, and the original thereof shall be kept with said Journal.

**SURRENDER OF CERTIFICATE  
TO PRACTICE MEDICINE AND SURGERY**

I, Glenn Leon Heigerick, D.O., am aware of my rights to representation by counsel, the right of being formally charged and having a formal adjudicative hearing, and do hereby freely execute this document and choose to take the actions described herein.

I, Glenn Leon Heigerick, D.O., do hereby voluntarily, knowingly, and intelligently surrender my certificate to practice medicine and surgery, No. 34-000327, to the State Medical Board of Ohio, thereby relinquishing all rights to practice medicine and surgery in Ohio.

I understand that as a result of the surrender herein that I am no longer permitted to practice medicine and surgery in any form or manner in the State of Ohio.

I agree that I shall be ineligible for, and shall not apply for, reinstatement of certificate to practice medicine and surgery No. 34-000327 or issuance of any other certificate pursuant to Chapters 4730. or 4731., Ohio Revised Code, on or after the date of signing this Surrender of Certificate to Practice Medicine and Surgery. Any such attempted reapplication shall be considered null and void and shall not be processed by the Board.

I hereby authorize the State Medical Board of Ohio to enter upon its Journal an Order revoking my certificate to practice medicine and surgery, No. 34-000327, in conjunction with which I expressly waive the provision of Section 4731.22(B), Ohio Revised Code, requiring that six (6) Board Members vote to revoke said certificate, and further expressly and forever waive all rights as set forth in Chapter 119., Ohio Revised Code, including but not limited to my right to counsel, right to a hearing, right to present evidence, right to cross-examine witnesses, and right to appeal the Order of the Board revoking my certificate to practice medicine and surgery.

I, Glenn Leon Heigerick, D.O., hereby release the State Medical Board of Ohio, its members, employees, agents and officers, jointly and severally, from any and all liability arising from the within matter.

I stipulate and agree that I am taking the action described herein in lieu of formal disciplinary proceedings pursuant to Sections 4731.22(B)(5),(8) and (11), Ohio Revised Code, based upon my plea of guilty to one count of a violation of Section 2913.02, Ohio Revised Code, Theft; one count of a violation of Section 2913.47, Ohio Revised Code, Insurance Fraud; and one count of a violation of Section 3715.52, Ohio Revised Code, Prohibitions, all misdemeanors committed in the course of practice, as shown in the Bill of Information and Judgment Entry, attached hereto and fully incorporated herein.


