

Entry of Order

On APRIL 22, 1989, Rankin Ray Pickens, D.O., executed a Voluntary Surrender of his Certificate of Practice Osteopathic Medicine and Surgery with a consent to revocation, which document is attached hereto and fully incorporated herein.

In consideration of the foregoing and of Doctor Pickens' express waiver of the provision of Section 4731.22(B), Ohio Revised Code, requiring that six (6) Board Members vote to revoke said certificate, it is hereby ORDERED that Certificate No. 622 authorizing Rankin Ray Pickens, D.O., to practice osteopathic medicine and surgery be REVOKED, effective on or before June 3, 1989.

This Order is hereby entered upon the Journal of the State Medical Board for the 23 day of May, 1989, and the original thereof shall be kept with said Journal.

VOLUNTARY SURRENDER OF CERTIFICATE
TO PRACTICE OSTEOPATHIC MEDICINE AND SURGERY

I, Rankin R. Pickens, D.O., am aware of my rights to representation by counsel, the right of being formally charged and having a formal adjudicative hearing, and do hereby freely execute this document and choose to take the actions described herein.

I, Rankin R. Pickens, D.O. do hereby voluntarily, knowingly, and intelligently surrender all rights to practice osteopathic medicine under my certificate to practice osteopathic medicine and surgery, No. 622, to the Ohio State Medical Board.

I agree that I shall be ineligible for, and shall not apply for, reinstatement of certificate to practice osteopathic medicine and surgery No. 622, or issuance of any other certificate pursuant to Chapters 4730. and 4731., Ohio Revised Code, on or after the date of signing this Voluntary Surrender of Certificate to Practice Osteopathic Medicine and Surgery.

I hereby authorize the State Medical Board of Ohio to enter upon its Journal an Order revoking my certificate to practice osteopathic medicine and surgery, No. 622, in conjunction with which I expressly waive the provision of Section 4731.22(B), Ohio Revised Code, requiring that six (6) Board Members vote to revoke said certificate, and further expressly and forever waive all rights as set forth in Chapter 119., Ohio Revised Code, including but not limited to my right to counsel, right to a hearing, right to present evidence, right to cross-examine witnesses, and right to appeal the Order of the Board revoking my certificate to practice osteopathic medicine and surgery.

I stipulate and agree that I am taking the action described herein in lieu of formal disciplinary proceedings pursuant to Section 4731.22(B), (2); Section 4731.22 (B)(3); and Section 4731.22 (B)(6), Ohio Revised Code.

This shall become effective. I will mail in my Ohio License and my annual card for 1989 on or before June 3, 1989.
