

CONSENT ORDER
BETWEEN
ARTHUR TESI, M.D.
AND
THE STATE MEDICAL BOARD

THIS CONSENT ORDER IS entered into by and between ARTHUR TESI, M.D., and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapters 4730. and 4731. of the Ohio Revised Code.

ARTHUR TESI, M.D., enters into this Consent Order being fully aware of his rights, including his right to be advised by counsel.

This Consent Order is entered into on the basis of the following statements, admissions, and understandings:

- A. ARTHUR TESI, M.D., admits that he did not complete the requisite number of Continuing Medical Education hours for the 1983-84 and 1985-86 bienniums, as required by Section 4731.281, Ohio Revised Code.
- B. ARTHUR TESI, M.D., has completed 132 credits in Category I for the 1983-84 and 1985-86 bienniums, which shall be applied toward each biennium in the following manner:

<u>1983-1984</u>	<u>1985-1986</u>
40 hrs. Category I credit	40 hrs. Category I credit
26 hrs. Category II credit	26 hrs. Category II credit

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal proceedings at this time, ARTHUR TESI, M.D., knowingly and voluntarily agrees with THE STATE MEDICAL BOARD OF OHIO to the following conditions:

- A. DR. TESI'S license to practice medicine and surgery in the State of Ohio shall be suspended for a period of thirty (30) days, beginning January 9, 1987 and ending February 8, 1987.
- B. DR. TESI shall provide documentation acceptable to the Board of satisfactory completion of the remaining 68 hours of Category II credit necessary to satisfy the CME requirement for 1983-84 and 1985-86.
- C. DR. TESI shall submit an application for reinstatement and shall pay all accompanying fees.

D. Subsequent to reinstatement of his license, ARTHUR TESI, M.D., shall remain on probation for two biennial registration periods, and shall submit documentation acceptable to the Board of satisfactory completion of the requisite hours of CME for each of the biennial registration periods.

It is AGREED AND UNDERSTOOD by and between both parties that this Consent Order shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.
