Dear Dr. Johnson:

After careful consideration of the testimony and evidence presented at your adjudication hearing on October 3, 1967, the State Medical Board issued the following order:

"Charles S. Johnson, Jr., M. D. (#17428) appeared before the State Medical Board for a hearing to determine whether or not his license to practice Medicine and Surgery (#17428), issued under the provisions of Chapter 4731, Ohio Revised Code, should be suspended or revoked for an alleged violation of the provisions of Section 4731.22 R. C. in that he was found guilty of a felony in the Montgomery County Common Pleas Court, Case No. 26069, on April 14, 1967.

Dr. Johnson was accompanied by his attorney, Mr. Lloyd O'Hara, of Dayton. Numerous witnesses from the Dayton area, including physicians, were presented. A legal transcript of this hearing was made.

Following the hearing and after consideration of the evidence presented, the Board issued the following order on motion of Dr. Crawford seconded by Dr. Ramsayer:

It is hereby ordered that the certificate of Dr. Charles S. Johnson, Jr. (#17428) be suspended for five (5) years beginning November 15, 1967. This suspension is to be stayed as of March 15, 1968 and Dr. Charles S. Johnson, Jr. placed on probation for the remainder of the five (5) year period under the same conditions provided in the entry of the Common Pleas Court of Montgomery County, Dayton, Ohio, Case # 26069. Dr. Charles S. Johnson, Jr. will be required to appear before the State Medical Board when requested during the probationary period.
