CONSENT AGREEMENT  
BETWEEN  
THOMAS E. OGDEN, M.D.

THE STATE MEDICAL BOARD OF OHIO

THIS CONSENT AGREEMENT is entered into by and between THOMAS E. OGDEN, and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapters 4730. and 4731. of the Ohio Revised Code.

THOMAS E. OGDEN enters into this agreement voluntarily, being aware of his rights.

This agreement is entered into on the basis of the following statements:

- A. THOMAS E. OGDEN voluntarily surrendered his certificate to practice medicine on December 3, 1976.
- B. THE STATE MEDICAL BOARD OF OHIO returned to THOMAS E. OGDEN his certificate to practice medicine on May 19, 1980 subject to several restrictions.
- C. THOMAS E. OGDEN desires to have certain of the restrictions upon his certificate to practice medicine removed from said certificate.

WHEREFORE, in consideration of the foregoing and of mutual promises hereinafter set forth, THOMAS E. OGDEN knowingly and voluntarily enters into the following agreement with THE STATE MEDICAL BOARD OF OHIO.

THOMAS E. OGDEN agrees to abide by the following terms and conditions:

- A. He agrees not to perform any anesthesiology or intensive care work until such time as THE STATE MEDICAL BOARD OF OHIO deems this limitation unnecessary; and
- B. He further agrees not to apply for reissuance of his DEA certificate until such time as THE STATE MEDICAL BOARD OF OHIO considers that his progress warrants it; and
- C. He further agrees to appear before THE STATE MEDICAL BOARD OF OHIO at three (3) month intervals after the date of signing this agreement as requested by THE STATE MEDICAL BOARD OF OHIO; and
- D. He further agrees to cooperate fully with THE STATE MEDICAL BOARD OF OHIO and its agents and employees, and, when requested, make his place of practice available for inspection; and
- E. He further agrees to obey all laws, rules, and regulations of the United States, the State of Ohio, and its political subdivisions, related to the practice of medicine.

This agreement is intended to supercede any prior agreement between the parties. Upon the consent of both parties, the terms and conditions of this agreement may be modified or terminated in writing. The terms and conditions of this agreement shall become effective on the 6<sup>th</sup> day of August, 1981.

THIS CONSENT AGREEMENT is entered into by and between THOMAS E. OGDEN, and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapters 4730. and 4731. of the Ohio Revised Code.

THOMAS E. OGDEN enters into this agreement voluntarily, being aware of his rights.

This agreement is entered into on the basis of the following statements:

- A. THOMAS E. OGDEN voluntarily surrendered his certificate to practice medicine on December 3, 1976.
- B. THOMAS E. OGDEN desires to have his certificate to practice medicine returned to him.

WHEREFORE, in consideration of the foregoing and of mutual promises hereinafter set forth, THOMAS E. OGDEN knowingly and voluntarily enters into the following agreement with THE STATE MEDICAL BOARD OF OHIO.

THOMAS E. OGDEN agrees to abide by the following terms and conditions:

- A. He will agree to limit his practice to no more than three (3) hours per day until such time as THE STATE MEDICAL BOARD OF OHIO deems this limitation unnecessary.
- B. He agrees to appear before THE STATE MEDICAL BOARD OF OHIO one (1) month after the date of signing this agreement, and at subsequent intervals as requested by the STATE MEDICAL BOARD OF OHIO.
- C. He agrees not to apply for reissuance of his DEA certificate until such time as THE STATE MEDICAL BOARD OF OHIO considers that his progress warrants it.
- D. He will cooperate fully with THE STATE MEDICAL BOARD OF OHIO and its agents and employees, and, when requested, make his place of practice available for inspection.
- E. He will obey all laws, rules, and regulations of the United States, the State of Ohio, and its political subdivisions, related to the practice of medicine.

Upon the consent of both parties, the terms and conditions of this agreement may be modified or terminated in writing. The terms and conditions of this agreement shall become effective on the 19<sup>th</sup> day of May, 1980.


VOLUNTARY SURRENDER OF LICENSE  
TO PRACTICE MEDICINE AND SURGERY


I, Thomas F OGDEN M. D. after being fully advised of my rights, do hereby freely execute this document and choose to take the actions described herein.


I understand that as a result of the surrender herein that I am no longer permitted to practice medicine and surgery in any form or manner in the State of Ohio.



You are advised that you are entitled to a hearing on this matter if you request such hearing within thirty (30) days of the time of mailing of this notice.

You are further advised that you are entitled to appear at such hearing in person, or by your attorney, or you may present your position, arguments, or contentions in writing, and that at the hearing you may present evidence and examine witnesses appearing for or against you.

In the event that there is no request for such hearing made within thirty (30) days of the time of mailing of this notice, the State Medical Board may, in your absence and upon consideration of this matter, determine whether or not to limit, reprimand, revoke, suspend, place on probation, refuse to register, or reinstate your certificate to practice medicine and surgery.
