CONSENT AGREEMENT
BETWEEN
RAUL TRAMONTANA, M.D.
AND
THE STATE MEDICAL BOARD OF OHIO**

THIS CONSENT AGREEMENT is entered into by and between **RAUL TRAMONTANA, M.D.** and **THE STATE MEDICAL BOARD OF OHIO**, a state agency charged with enforcing Chapter 4731., Ohio Revised Code.

RAUL TRAMONTANA, M.D., enters into this Agreement being fully informed of his rights under Chapter 119., Ohio Revised Code, including the right to representation by counsel and the right to a formal adjudicative hearing on the issues considered herein.

This Consent Agreement is entered into on the basis of the following stipulations, admissions and understandings:

- A. **THE STATE MEDICAL BOARD OF OHIO** is empowered by Section 4731.22 (B) (19), Ohio Revised Code, to limit, revoke, suspend a certificate, refuse to register or reinstate an applicant, or reprimand or place on probation the holder of a certificate for inability to practice according to acceptable and prevailing standards of care by reason of mental illness or physical illness, including, but not limited to, physical deterioration that adversely affects cognitive, motor or perceptive skills.
- B. **RAUL TRAMONTANA, M.D.**, is licensed to practice medicine and surgery in the State of Ohio.
- C. On or about April 11, 1989, your staff privileges at Wilson Memorial Hospital in Sidney, Ohio, were suspended for fourteen (14) days, pending a review of your behavior at the hospital by a medical staff committee. Subsequently, you did resign your staff privileges from the hospital.
- D. On or about January 23, 1990, **THE STATE MEDICAL BOARD OF OHIO** directed **DOCTOR TRAMONTANA** to submit to a mental and/or physical examination by the authority of Section 4731.22 (B) (19), Ohio Revised Code.
- E. Upon completion of the **BOARD** ordered psychiatric examination of **DOCTOR TRAMONTANA**, the evaluation concluded that **DOCTOR TRAMONTANA** was able to continue to practice medicine and surgery under the supervision of **THE STATE MEDICAL BOARD OF OHIO**. As part of this supervisory situation, **DOCTOR TRAMONTANA** AGREES to seek additional psychiatric monitoring and/or treatment.

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal proceedings at this time, **RAUL TRAMONTANA, M.D.**, knowingly and voluntarily agrees with **THE STATE MEDICAL BOARD OF OHIO** (hereinafter **BOARD**), to the following:

1. DOCTOR TRAMONTANA shall appear in person for interviews before the full BOARD or its designated representative at six (6) month intervals, or as otherwise directed by the BOARD;
2. Within thirty (30) days of the effective date of this Agreement DOCTOR TRAMONTANA shall submit to the BOARD for its prior approval the name and qualifications of a psychiatrist of his choice. Upon approval by the full BOARD, DOCTOR TRAMONTANA shall undergo and continue psychiatric monitoring and/or treatment every three (3) months, or as otherwise directed by the treating psychiatrist. DOCTOR TRAMONTANA shall ensure that psychiatric reports are forwarded by his treating psychiatrist to the BOARD every three (3) months, or as otherwise directed by the BOARD.

The above described terms may be amended or terminated in writing at any time upon the agreement of both parties. However, this Agreement shall remain in force for a minimum of two (2) years prior to any request for termination of said Agreement.

DOCTOR TRAMONTANA hereby releases THE STATE MEDICAL BOARD OF OHIO, its Members, Employees, Agents, Officers and Representatives, jointly and severally, from any and all liability arising from the within matter.
