

CONSENT AGREEMENT

BETWEEN

ARTHUR O. CHARPENTIER, JR., M.D.

AND

THE STATE MEDICAL BOARD OF OHIO

THIS CONSENT AGREEMENT is entered into by and between ARTHUR O. CHARPENTIER, JR., M.D., and THE STATE MEDICAL BOARD OF OHIO (hereinafter "BOARD").

ARTHUR O. CHARPENTIER, JR., M.D., knowingly and voluntarily enters into this agreement being fully aware of his rights including his right to consult with and be advised by legal counsel.

Upon payment of the past and current registration fees and in consideration of the promises hereinafter set forth, the BOARD agrees to reinstate on a limited basis ARTHUR O. CHARPENTIER'S certificate to practice medicine or surgery.

WHEREFORE, ARTHUR O. CHARPENTIER, JR., M.D., promises and agrees to abide by the following terms and conditions:

- 1. He will submit to periodic surprise urine screenings.
- 2. He will continue to attend the impaired physicians' treatment program with Doctor Perry Ayres on the same time basis as in the past.
- 3. He will report in person, at periodic intervals as requested, to the BOARD or a designated representative thereof for the purpose of reporting on his current activities and health.
- 4. He will be under surveillance by his employer and a BOARD investigator. The employer and investigator will submit periodic reports on the surveillance to the BOARD.

If, in the discretion of the BOARD, ARTHUR O. CHARPENTIER, JR., M.D., appears to have violated or breached any term or condition of this agreement, the BOARD reserves the right, upon notice and the opportunity to be heard, to take any disciplinary action it deems appropriate under the provisions of Section 4731.22 of the Revised Code.

Upon the written consent of both parties, the terms and conditions of this agreement may be modified or terminated.

The terms and conditions of this agreement shall become effective on the 27th day of January, 19 82 and shall supersede the Consent Agreement of October 20, 1981.

1. He will submit to periodic surprise urine screenings.

3. He will report in person, at periodic intervals as requested, to the Board or a designated representative thereof for the purpose of reporting on his current activities and health.
4. He will be under surveillance by his employer and a Board investigator. The employer and investigator will submit periodic reports on the surveillance to the Board.
5. He will not apply for a permit from the federal Drug Enforcement Administration to prescribe, administer, order, or dispense controlled substances.

If, in the discretion of the BOARD, ARTHUR O. CHARPENTIER, JR., M.D., appears to have violated or breached any term or condition of this agreement, the BOARD reserves the right, upon notice and the opportunity to be heard, to take any disciplinary action it deems appropriate under the provisions of Section 4731.22 of the Revised Code.

Upon the written consent of both parties, the terms and conditions of this agreement may be modified or terminated.

The terms and conditions of this agreement shall become effective on the 20th day of October, 1981.
