On April 11, 2000, Haradhan Banerjee, M.D. executed a Voluntary Surrender of his Certificate to practice medicine and surgery in the State of Ohio with a consent to revocation, which document is attached hereto and fully incorporated herein.

In consideration of the foregoing and of Dr. Banerjee's express waiver of the provision of Section 4731.22(B), Ohio Revised Code, requiring that six (6) Board members vote to revoke said certificate, it is hereby ORDERED that Certificate No. 35-044066 authorizing Haradhan Banerjee, M.D., to practice medicine be permanently REVOKED, effective April 20, 2000.

This Order is hereby entered upon the Journal of the State Medical Board of Ohio for the 20th day of April, 2000, and the original thereof shall be kept with said Journal.

SURRENDER OF CERTIFICATE
TO PRACTICE MEDICINE AND SURGERY**

I, HARADHAN BANERJEE, M.D., am aware of my rights to representation by counsel, the right of being formally charged and having a formal adjudicative hearing, and do hereby freely execute this document and choose to take the actions described herein.

I, HARADHAN BANERJEE, M.D., do hereby voluntarily, knowingly, and intelligently surrender my certificate to practice medicine and surgery, No. 35-044066, to the State Medical Board of Ohio, thereby relinquishing all rights to practice medicine and surgery in Ohio.

I understand that as a result of the surrender herein that I am no longer permitted to practice medicine and surgery in any form or manner in the State of Ohio.

I agree that I shall be ineligible for, and shall not apply for, reinstatement of certificate to practice medicine and surgery No. 35-044066 or issuance of any other certificate pursuant to Chapters 4730. or 4731., Ohio Revised Code, on or after the date of signing this Surrender of Certificate to Practice Medicine and Surgery. Any such attempted reapplication shall be considered null and void and shall not be processed by the Board.

I hereby authorize the State Medical Board of Ohio to enter upon its Journal an Order permanently revoking my certificate to practice medicine and surgery, No. 35-044066, in conjunction with which I expressly waive the provision of Section 4731.22(B), Ohio Revised Code, requiring that six (6) Board Members vote to revoke said certificate, and further expressly and forever waive all rights as set forth in Chapter 119., Ohio Revised Code, including but not limited to my right to counsel, right to a hearing, right to present evidence, right to cross-examine witnesses, and right to appeal the Order of the Board revoking my certificate to practice medicine and surgery.

I, HARADHAN BANERJEE, M.D., hereby release the State Medical Board of Ohio, its members, employees, agents and officers, jointly and severally, from any and all liability arising from the within matter.

This document shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.

Further, this information may be reported to appropriate organizations, data banks and governmental bodies.

I stipulate and agree that I am taking the action described herein in lieu of formal disciplinary proceedings pursuant to Section 4731.22(B)(3) and (9), Ohio Revised Code, based upon my plea of guilty to three (3) felony counts of drug trafficking, in violation of Section 2925.03, Ohio Revised Code. Copies of the Court documents in Case No. CR 384747, Cuyahoga County Court of Common Pleas, are attached hereto and fully incorporated herein.



DEFENDANT IN COURT WITH COUNSEL ROGER TIKTIN. ON A FORMER DAY OF COURT DEFENDANT PLEAD GUILTY TO TRAFFICKING IN DRUGS ORC 2925.03 FELONY FIVE SENATE BILL TWO AS CHARGED IN COUNTS ONE, TWO AND THREE.

DEFENDANT AND PROSECUTOR ADDRESS THE COURT.

THE COURT CONSIDERED ALL OF THE REQUIRED FACTORS OF THE LAW.

THE COURT FINDS THAT A COMMUNITY CONTROL SANCTION WILL ADEQUATELY PROTECT THE PUBLIC AND WILL NOT DEEMAN THE SERIOUSNESS OF THE OFFENSE. IT IS THEREFORE ORDERED THAT THE DEFENDANT IS SENTENCED TO 2 YEARS OF COMMUNITY CONTROL, UNDER THE SUPERVISION OF THE ADULT PROBATION DEPARTMENT WITH THE FOLLOWING CONDITION (S): DEFENDANT TO GIVE UP MEDICAL LICENSE; ATTEND MENTAL HEALTH COUNSELING.

VIOLATION OF THE TERMS AND CONDITIONS MAY RESULT IN MORE RESTRICTIVE SANCTIONS, A PRISON TERM OF 11 MONTHS AS TO EACH OF COUNTS ONE, TWO AND THREE, COUNTS TO RUN CONCURRENT OR EXTENSIONS, AS PROVIDED BY LAW.

THE DEFENDANT IS ORDERED TO REPORT TO THE ADULT PROBATION DEPARTMENT.

DEFENDANT IS TO PAY COURT COSTS AND A \$750.00 FINE. DEFENDANT IS TO PAY RESTITUTION OF \$12,500.00 THROUGH PROBATION DEPARTMENT.
