THIS CONSENT AGREEMENT is entered into, by and between ALFRED C. NEPTUNE, M.D., and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapters 4730. and 4731. of the Ohio Revised Code.

ALFRED C. NEPTUNE, M.D., enters into this Agreement being fully aware of his rights, including his right to be advised by counsel.

This Agreement is entered into on the basis of the following statements, admissions and understandings:

- A) ALFRED C. NEPTUNE, M.D. admits that he has been chemically dependent on Demerol, a Schedule II substance.
- B) ALFRED C. NEPTUNE, M.D. admits that said chemical dependency started in April of 1983.
- C) ALFRED C. NEPTUNE, M.D. admits that he was a patient at Gateway Rehabilitation Center in Aliquippa, Pennsylvania from July 25, 1983 through August 22, 1983.
- D) ALFRED C. NEPTUNE, M.D. admits that he surrendered his D.E.A. certificate to the Ohio State Pharmacy Board on September 16, 1983.
- E) ALFRED C. NEPTUNE, M.D. admits that he entered the Medical Association of Georgia's Impaired Physicians Program on December 12, 1983 and was discharged March 30, 1984.

WHEREAS, in lieu of a formal adjudication hearing DR. NEPTUNE and the BOARD have agreed to enter into this CONSENT AGREEMENT which the parties have resolved to be in their mutual best interests.

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, ALFRED C. NEPTUNE, M.D., and the STATE MEDICAL BOARD OF OHIO hereby CONSENT and AGREE to the following terms and conditions:

1. DR. NEPTUNE shall attend Alcoholics Anonymous meetings at least two (2) times every week.
2. DR. NEPTUNE shall unequivocally refrain from the personal use of any alcohol or any controlled substance.
3. DR. NEPTUNE agrees to continue to participate in an Impaired Physicians Program.
4. DR. NEPTUNE agrees to satisfactorily complete the "after care contract" which he entered into with the Medical Association of Georgia's Impaired Physicians Program.
5. DR. NEPTUNE shall immediately notify the State Medical Board of Ohio if he returns to a practice of medicine in Ohio.
6. DR. NEPTUNE agrees to obey all federal, state and local laws.
7. DR. NEPTUNE further agrees to report to the BOARD or the BOARD's Secretary as determined to be necessary.

If, in the discretion of the Secretary of THE STATE MEDICAL BOARD OF OHIO, ALFRED C. NEPTUNE, M.D., appears to have violated or breached any terms or conditions of this agreement, THE STATE MEDICAL BOARD OF OHIO reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including, but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this agreement.

Upon consent of both parties, the terms and conditions of this agreement may be modified or terminated in writing.

The terms and conditions of this agreement shall become effective on the 18th day of August, 1984.

IT IS AGREED AND UNDERSTOOD by and between the parties that this Consent Agreement shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.
