BAHMAN YAMINI-SHARIF, M.D., knowingly and voluntarily enters into this agreement being fully aware of his rights including his right to consult and be advised by legal counsel.

Upon payment of current registration fees and in consideration of the promises hereinafter set forth, the BOARD agrees to allow BAHMAN YAMINI-SHARIF, M.D., to apply for a DEA certificate.

WHEREFORE, BAHMAN YAMINI-SHARIF, M.D., promises and agrees to abide by the following terms and conditions:

1. He will appear before the BOARD in six months if he remains in Ohio and as otherwise determined by the Board.

If, in the discretion of the BOARD, BAHMAN YAMINI-SHARIF, M.D., appears to have violated or breached any term or condition of this agreement, the BOARD reserves the right, upon notice and the opportunity to be heard to take any disciplinary action it deems appropriate under the provisions of Section 4731.22 of the Revised Code.

Upon the consent of both parties, the terms and conditions of this agreement may be modified or terminated.

This Consent Agreement supersedes all previous Consent Agreements between BAHMAN YAMINI-SHARIF, M.D., and the BOARD.

The terms and conditions of this agreement shall become effective on the 5th day of July, 1983.

If, in the discretion of the BOARD, BAHMAN YAMINI-SHARIF, M.D., appears to have violated or breached any term or condition of this agreement, the BOARD reserves the right, upon notice and the opportunity to be heard to take any disciplinary action it deems appropriate under the provisions of Section 4731.22 of the Revised Code.

Upon the written consent of both parties, the terms and conditions of this agreement may be modified or terminated.

The terms and conditions of this agreement shall become effective on the Sept day of 23, 1982.
