

AMENDED
CONSENT AGREEMENT
BETWEEN
CATALINA M. LEE, M. D.
AND
THE STATE MEDICAL BOARD OF OHIO

THIS AMENDED CONSENT AGREEMENT is entered into by and between CATALINA M. LEE, M. D. and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapters 4730. and 4731. of the Ohio Revised Code.

WHEREAS, in lieu of a formal adjudication hearing, DR. LEE and the BOARD have agreed to enter into this AMENDED CONSENT AGREEMENT which the parties have resolved to be in their mutual best interests.

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, CATALINA M. LEE, M. D., and THE STATE MEDICAL BOARD OF OHIO hereby CONSENT and AGREE to the following terms and conditions:

- 1) THE STATE MEDICAL BOARD OF OHIO agrees to issue a certificate to practice medicine or surgery to CATALINA M. LEE, M. D.
- 2) DR. LEE agrees that she will practice as a Staff Psychiatrist in a State of Ohio Hospital or Mental Health Center under the supervision of a medical director for at least twelve (12) months before engaging in unsupervised medical practice.
- 3) CATALINA M. LEE, M. D. agrees to appear before the Medical Board six (6) months from the date of receiving said certificate to practice medicine.

If, in the discretion of the Secretary of THE STATE MEDICAL BOARD OF OHIO, CATALINA M. LEE, M. D. appears to have violated or breached any terms or conditions of this Agreement, THE STATE MEDICAL BOARD OF OHIO reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including, but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this Agreement.

Upon consent of both parties, the terms and conditions of this Amended Agreement may be modified or terminated in writing.

The terms and conditions of this Amended Agreement shall become effective upon signature of both parties to the Agreement.

It is agreed and understood by the parties that this Amended Consent Agreement shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.

- 3) CATALINA M. LEE, M. D. agrees to appear before the Medical Board six (6) months from the date of receiving said certificate to practice medicine.

If, in the discretion of the Secretary of THE STATE MEDICAL BOARD OF OHIO, CATALINA M. LEE, M. D. appears to have violated or breached any terms or conditions of this agreement, THE STATE MEDICAL BOARD OF OHIO reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including, but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this agreement.

Upon consent of both parties, the terms and conditions of this agreement may be modified or terminated in writing.

The terms and conditions of this agreement shall become effective upon signature of both parties to the agreement.

It is agreed and understood by the parties that this Consent Agreement shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.
