

CONSENT AGREEMENT
BETWEEN
BRIAN S. SULLIVAN, M.D.
AND
THE STATE MEDICAL BOARD OF OHIO

THIS CONSENT AGREEMENT is entered into, by and between BRIAN S. SULLIVAN, M.D. and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapters 4730. and 4731. of the Ohio Revised Code.

BRIAN S. SULLIVAN, M.D., enters into this AGREEMENT being fully cognizant of all of his rights, including but not limited to, his right to be advised by counsel.

This AGREEMENT is entered into on the basis of the following statements, admissions, and understandings:

- (A) BRIAN S. SULLIVAN, M.D., admits that he has been chemically dependent on various drugs and mixed substances.
- (B) BRIAN S. SULLIVAN, M.D., admits that he has undergone treatment at the Mayo Clinic, Alcohol/Drug Dependency Unit and Aftercare Therapy at the Cleveland Clinic Foundation for said chemical dependency.
- (C) BRIAN S. SULLIVAN, M.D., wishes to obtain a license to practice medicine and surgery in Ohio.

WHEREAS, DR. SULLIVAN and the BOARD have agreed to enter into this CONSENT AGREEMENT which the parties have resolved to be in their mutual best interests.

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, BRIAN S. SULLIVAN, M.D., and the STATE MEDICAL BOARD OF OHIO hereby CONSENT and AGREE to the following terms and conditions:

1. DR. SULLIVAN shall attend Alcoholics Anonymous meetings and keep a log of his attendance at such meetings, indicating the time, location and date of said meeting therein. DR. SULLIVAN shall also bring this log with him when appearing before the BOARD pursuant to paragraph 5 and make same available to the BOARD at that time.
2. DR. SULLIVAN shall continue to actively participate in After-care Therapy and monitoring at the Cleveland Clinic Foundation, including routine individual counseling visits at the Cleveland Clinic Drug and Alcohol Rehabilitation Program.
3. DR. SULLIVAN shall absolutely refrain from the personal use of all drugs and alcohol, with the exception of Antabuse, administered solely by Dr. Gregory Collins.
4. DR. SULLIVAN shall be under the care of his monitoring physician, Dr. Gregory Collins, who shall submit status reports concerning DR. SULLIVAN every ninety (90) days to the BOARD.
5. DR. SULLIVAN shall personally appear before the BOARD, or a designated representative thereof, every three (3) months, beginning three (3) months from the effective date of this AGREEMENT.


Upon compliance with and in consideration of the terms and conditions as set out in paragraphs 1 through 5 above, and upon satisfaction of all other requirements for licensure, BRIAN S. SULLIVAN, M.D., shall be issued a license to practice medicine and surgery in Ohio.

If, in the discretion of the Secretary of THE STATE MEDICAL BOARD OF OHIO, BRIAN S. SULLIVAN, M.D., appears to have violated or breached any terms or conditions of this AGREEMENT, THE STATE MEDICAL BOARD OF OHIO reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including, but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this Agreement.

Upon consent of both parties, the terms and conditions of this Agreement may be modified or terminated in writing.

The terms and conditions of this Agreement shall become effective on the 15th day of August, 1986.

IT IS AGREED AND UNDERSTOOD by and between the parties that this CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.
