

**CONSENT AGREEMENT  
BETWEEN  
HAVA TABENKIN, M.D.  
AND  
THE STATE MEDICAL BOARD OF OHIO**

THIS CONSENT AGREEMENT is entered into by and between Hava Tabenkin, M.D. and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapter 4731., Ohio Revised Code.

Hava Tabenkin, M.D. enters into this Agreement being fully informed of his rights under Chapter 119., Ohio Revised Code, including the right to representation by counsel and the right to a formal adjudicative hearing on the issues considered herein.

This Consent Agreement is entered into on the basis of the following stipulations, admissions and understandings:

- A. THE STATE MEDICAL BOARD OF OHIO is empowered by Section 4731.22 (B)(20), Ohio Revised Code, to limit, revoke, suspend a certificate, refuse to register or reinstate an applicant, or reprimand or place on probation the holder of a certificate for "violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provisions of this chapter or any rule promulgated by the board."
- B. THE STATE MEDICAL BOARD OF OHIO is empowered by Section 4731.22 (A), Ohio Revised Code, to limit, revoke, suspend a certificate, refuse to register or reinstate an applicant, or reprimand or place on probation the holder of a certificate for committing "fraud, misrepresentattion, or deception in applying for or securing any license or certificate issued by the board."
- C. THE STATE MEDICAL BOARD OF OHIO is empowered by Section 4731.22 (B)(5), Ohio Revised Code, to limit, revoke, suspend a certificate, refuse to register or reinstate an applicant, or reprimand or place on probation the holder of a certificate for "publishing a false, fraudulent, deceptive, or misleading statement."
- D. THE STATE MEDICAL BOARD OF OHIO enters into this Consent Agreement in lieu of formal proceedings based upon the violation of Sections 4731.22(A), (B)(5) and (B)(20) as detailed in Paragraphs F and G below, and expressly reserves the right to institute formal proceedings based upon any other violations of Chapter 4731. of the Revised Code, whether occurring before or after the effective date of this Agreement.

E. HAVA TABENKIN, M.D. is licensed to practice medicine and surgery in the State of Ohio, with certificate number 60373.

F. HAVA TABENKIN, M.D. ADMITS that in completing <sup>her</sup> his application card for renewal of his certificate to practice medicine or surgery for the 1994 - 1996 biennial registration period, <sup>she</sup> he did certify that <sup>she</sup> he had completed during the preceding biennium the requisite hours of continuing medical education, as required by Section 4731.281, Ohio Revised Code.

G. HAVA TABENKIN, M.D. ADMITS that, in fact, <sup>she</sup> he had not completed the requisite hours of continuing medical education as required by Section 4731.281, Ohio Revised Code, at the time of certification, but did complete the requisite hours subsequently.

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal proceedings at this time, Hava Tabenkin, M.D. knowingly and voluntarily agrees with THE STATE MEDICAL BOARD OF OHIO, (hereinafter BOARD), to the following PROBATIONARY terms, conditions and limitations:

1. DOCTOR TABENKIN shall obey all federal, state and local laws, and all rules governing the practice of medicine in Ohio;
2. Within thirty (30) days after the end of each of the next three (3) biennial registration periods following the effective date of this agreement, DOCTOR TABENKIN shall submit documentation acceptable to the BOARD of satisfactory completion of the requisite hours of continuing medical education;
3. Should DOCTOR TABENKIN elect not to renew his Ohio certificate to practice medicine and surgery during the duration of this consent agreement, DOCTOR TABENKIN shall notify the BOARD in writing. Periods of time during which DOCTOR TABENKIN does not maintain his license as current will not apply to the reduction of the three (3) biennial registration periods for which documentation must be submitted.

If, in the discretion of the Secretary of THE STATE MEDICAL BOARD OF OHIO, DOCTOR TABENKIN appears to have violated or breached any term or condition of this Agreement, THE STATE MEDICAL BOARD OF OHIO reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this Agreement.

DOCTOR TABENKIN acknowledges that <sup>she</sup> he has had an opportunity to ask questions concerning the terms of this Agreement and that all questions asked have been answered in a satisfactory manner.

Any action initiated by the BOARD based on alleged violations of this Consent Agreement shall comply with the Administrative Procedure Act, Chapter 119., Ohio Revised Code.

DOCTOR TABENKIN hereby releases THE STATE MEDICAL BOARD OF OHIO, its Members, Employees, Agents, Officers and Representatives jointly and severally from any and all liability arising from the within matter.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code, and shall become effective upon the last date of signature below.

Further, this information may be reported to appropriate organizations, data banks and governmental bodies.
