CONSENT AGREEMENT
BETWEEN
ANDREW H. BOYLE, D.P.M.
AND
THE STATE MEDICAL BOARD OF OHIO

THIS CONSENT AGREEMENT is entered into, by and between ANDREW H. BOYLE, D.P.M. and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapters 4730. and 4731. of the Ohio Revised Code.

ANDREW H. BOYLE, D.P.M., enters into this AGREEMENT being fully aware of all his rights, including but not limited to, his right to be advised by counsel.

This AGREEMENT is entered into on the basis of the following statements, admissions, and understandings:

- (A) ANDREW H. BOYLE, D.P.M. states that he graduated from the Ohio College of Podiatric Medicine, Cleveland, Ohio on May 27, 1983.
- (B) ANDREW H. BOYLE, D.P.M. further states that he has not practiced podiatric medicine from May, 1983 through the present.

WHEREAS, DR. BOYLE and the BOARD have agreed to enter into this CONSENT AGREEMENT which the parties have resolved to be in their mutual best interests.

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, ANDREW H. BOYLE, D.P.M., and the STATE MEDICAL BOARD OF OHIO hereby CONSENT and AGREE to the following terms and conditions:

- 1. THE STATE MEDICAL BOARD OF OHIO agrees to issue a license to practice podiatric medicine to ANDREW H. BOYLE, D.P.M.
- 2. ANDREW H. BOYLE, D.P.M., agrees that he will only practice podiatry under the supervision of a licensed podiatrist for a period of one (1) year.
- 3. At the end of one (1) year of supervised practice, DR. BOYLE shall provide proof, satisfactory to the BOARD, of such supervised practice. Upon acceptance of said proof the terms and conditions of this agreement shall be terminated.

Upon the consent of both parties, the terms and conditions of this agreement may be modified or terminated in writing by the STATE MEDICAL BOARD or the Secretary of the STATE MEDICAL BOARD.

If, in the discretion of the Secretary of the STATE MEDICAL BOARD OF OHIO, ANDREW H. BOYLE, D.P.M., appears to have violated or breached any terms or conditions of this agreement, THE STATE MEDICAL BOARD OF OHIO reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including, but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this agreement.

It is AGREED AND UNDERSTOOD by and between both parties that this CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.

The terms and conditions of this agreement shall become effective upon the signing of both parties.
