
Dear Mr. Zimerla:



FINDINGS, ORDER AND JOURNAL ENTRY

This matter came on for consideration after a citation letter was issued to James H. Zimerla, P.A., by the State Medical Board of Ohio on October 10, 1990.


On October 10, 1990 notice was given to Mr. Zimerla that the State Medical Board intended to consider disciplinary action regarding his registration to practice as a Physician's Assistant in Ohio, and that he was entitled to a hearing if such hearing was requested within thirty (30) days of the mailing of said notice. In accordance with Section 119.09, Ohio Revised Code, said notice was sent via certified mail, return receipt request, to the last known business address of Mr. Zimerla, that being 1600 Harvard Avenue, Cleveland, Ohio, 44105.

No request for hearing has been received and more than thirty (30) days have elapsed since the mailing of the aforesaid notice.

WHEREFORE, it is hereby ORDERED that for the reasons outlined in the October 10, 1990 letter of notice, which is attached hereto and attached herein, accordingly, the Ohio Physician's Assistant registration of JAMES H. ZIMERLA, P.A., be indefinitely suspended until such time as he is approved for registration to an employer having an approved P.A. Utilization Plan.

This ORDER shall become effective immediately.

This ORDER is hereby entered upon the Journal of the State Medical Board of Ohio for the 9th day of January, 1991 and the original thereof shall be kept with said Journal.

Dear Mr. Zimerla:

In accordance with Chapter 119., Ohio Revised Code, you are hereby notified that the State Medical Board of Ohio intends to determine whether or not to suspend, or revoke your registration, or to refuse to register you to practice as a physician's assistant for one or more of the following reasons:

- (1) On or about February 11, 1977 you were issued a certificate of registration as a physician's assistant by the State Medical Board of Ohio. As part of your application for registration at that time, Anthony M. Puelo, M.D. was listed as your employing physician.
- (2) You remained registered as a physician's assistant in the State of Ohio from February 11, 1977, to the present.
- (3) In fact, you have been employed by the Aluminum Company of America, a corporation, for as long as you have been registered as a physician's assistant, and have never been employed by a physician or group of physicians.

Such acts, conduct, and/or omissions as alleged in paragraphs (1) through (3) above, individually and/or collectively, constitute "(f)ailure to comply with the requirements of this chapter or any rules adopted by the Board," as that clause is used in Section 4730.05(B), Ohio Revised Code, to wit: Sections 4730.02(A) and 4730.02(B), Ohio Revised Code.

Pursuant to Chapter 119., Ohio Revised Code, you are hereby advised that you are entitled to a hearing in this matter. If you wish to request such hearing, the request must be made in writing and must be received in the offices of the State Medical Board within thirty (30) days of the time of mailing of this notice.

You are further advised that you are entitled to appear at such hearing in person, or by your attorney, or by such other representative as is permitted to practice before this agency, or you may present your position, arguments, or contentions in writing, and that at the hearing you may present evidence and examine witnesses appearing for or against you.

In the event that there is no request for such hearing received within thirty (30) days of the time of mailing of this notice, the State Medical Board may, in your absence and upon consideration of this matter, determine whether or not to limit, revoke, suspend, refuse to register or reinstate your certificate to practice as a physician's assistant or to reprimand or place you on probation.
