**CONSENT AGREEMENT
BETWEEN
ROBERT S. DAVIS, P.A.
AND
THE STATE MEDICAL BOARD OF OHIO**

This CONSENT AGREEMENT is entered into by and between ROBERT S. DAVIS, P.A., and THE STATE MEDICAL BOARD OF OHIO, a state agency charged with enforcing Chapter 4730., Ohio Revised Code.

ROBERT S. DAVIS, P.A., enters into this CONSENT AGREEMENT being fully informed of his rights under Chapter 119., Ohio Revised Code, including the right to representation by counsel and the right to a formal adjudicative hearing on the issues considered herein.

BASIS FOR ACTION

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

- A. THE STATE MEDICAL BOARD OF OHIO is empowered by Section 4730.25(B)(2), Ohio Revised Code, to limit, revoke, suspend a certificate, refuse to register or reinstate an applicant, or reprimand or place on probation the holder of a certificate for, “[f]ailure to comply with the requirements of this chapter, Chapter 4731. of the Revised Code, or any rules adopted by the board;” to wit: Section 4730.02, Ohio Revised Code, Prohibitions.
- B. THE STATE MEDICAL BOARD OF OHIO enters into this CONSENT AGREEMENT in lieu of formal proceedings based upon the violation of Section 4730.25(B)(2), Ohio Revised Code, as set forth in Paragraph D below, and expressly reserves the right to institute formal proceedings based upon any other violations of Chapter 4730. of the Revised Code, whether occurring before or after the effective date of this Agreement.
- C. ROBERT S. DAVIS, P.A., has submitted an application for a certificate of registration as a physician assistant in the State of Ohio.
- D. ROBERT S. DAVIS, P.A., STATES that he was employed as a clinical assistant by Akron General Medical Center from in or about January, 1989 to May, 2000. MISTER DAVIS ADMITS that, during his employment with Akron General Medical Center, he functioned as a physician assistant. MISTER DAVIS further ADMITS that his duties at

Akron General Medical Center included assisting in surgery, changing dressing, casting, assisting with traction set-ups, assisting residents with exams, reviewing lab values and x-rays before and after surgery, interviewing patients, answering patient questions, and assisting in fracture and dislocation reductions.

AGREED CONDITIONS

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal proceedings at this time, ROBERT S. DAVIS, P.A., shall be granted a certificate of registration as a physician assistant in the State of Ohio, and knowingly and voluntarily agrees with THE STATE MEDICAL BOARD OF OHIO, (hereinafter BOARD), to the following terms, conditions and limitations:

1. MISTER DAVIS is hereby REPRIMANDED;
2. Within thirty (30) days of the effective date of this CONSENT AGREEMENT, MISTER DAVIS shall provide a copy of this CONSENT AGREEMENT to all employers or entities with which he is under contract to provide health care services or is receiving training; and the Chief of Staff at each hospital where he is employed, has privileges or appointments. Further, MISTER DAVIS shall provide a copy of this CONSENT AGREEMENT to all employers or entities with which he contracts to provide health care services, or applies for or receives training, and the Chief of Staff at each hospital where he applies for employment, privileges or appointments;
3. Within thirty (30) days of the effective date of this CONSENT AGREEMENT, MISTER DAVIS shall provide a copy of this CONSENT AGREEMENT by certified mail, return receipt requested, to the proper licensing authority of any state or jurisdiction in which he currently holds any professional license. MISTER DAVIS further agrees to provide a copy of this CONSENT AGREEMENT by certified mail, return receipt requested, at time of application to the proper licensing authority of any state in which he applies for any professional license or reinstatement of any professional license. Further, MISTER DAVIS shall provide this BOARD with a copy of the return receipt as proof of notification within thirty (30) days of receiving that return receipt;

The above described terms, limitations and conditions may be amended or terminated in writing at any time upon the agreement of both parties.

FAILURE TO COMPLY

If, in the discretion of the Secretary and Supervising Member of the BOARD, MISTER DAVIS appears to have violated or breached any term or condition of this CONSENT AGREEMENT, the BOARD reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including, but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this CONSENT AGREEMENT.

ACKNOWLEDGMENTS/LIABILITY RELEASE

MISTER DAVIS acknowledges that he has had an opportunity to ask questions concerning the terms of this CONSENT AGREEMENT and that all questions asked have been answered in a satisfactory manner.

Any action initiated by the BOARD based on alleged violations of this CONSENT AGREEMENT shall comply with the Administrative Procedure Act, Chapter 119., Ohio Revised Code.


